## ORDER:

In her letter 3rd read above, the Principal Secretary, Women Development, Child Welfare & Disabled Welfare Department inter-alia, requested the Department to allot houses to adult, unmarried disabled persons treating them as separate unit. That Department has also informed that Group of Ministers comprising with Minister for WD,CW &DW, Minister for Agrl. &TM and Munister for Commercial Taxes, on behalf of the Government among other agreed to the decounds of disabled persons pertaining to Housing Department, viz:-i) Ground Floor of all flats taken up under INDIRAMMA scheme shall be reserved for disabled ii) The Type design of all such flats / houses should be changed to make them disabled friendly and iii) In case of Mentally Retarded persons the guardian shall be allotted house in the name of the Mentally Retarded person. That Department has requested this department to issue necessary orders on the above 185008

- Government have examined the matter in detail and after careful consideration hereby order as follows :-
  - Houses shall also be sanctioned to Adult un-married disabled persons treating 3) them as a separate unit / family.
  - Ground Floor of all flats taken up under INDIRAMMA scheme shall be reserved ii) for disabled.
  - The Type design of all such flats / houses shall be disabled friendly. m)
  - In case of Mentally Retarded persons, house shall be allotted to the guardian in iv) the name of the Mentally Retarded person.
- All the District Collectors / Executive Directors, AP State Housing Corporation / Munaging Director, AP State Housing Corporation Limited, Hyderabad shall take necessary action accordingly.
